The New York State Intellectual Disabilities/ Developmental Disabilities Nurses Association (NYSIDDDNA) was founded to promote Intellectual and Developmental Disabilities Nursing as a specialty area of practice.

The Association continues to support its members' activities in nursing law, education, research, and practice.

DDNA Update — November 2021

DDNA held the annual Membership meeting at the 2021 Virtual Education Conference that was held in May. Judy Stych, DDNA President, shared the following highlights:

2022 Conference: This will be the 30th Annual Educational Conference and will be held May 20-23, 2022 in San Antonio, Texas at the Grand Hyatt Hotel on the Riverwalk. Updates will be available on the DDNA website.

Transition from Chapters to Affiliates: Over the last few years, DDNA has been evaluating the current chapter structure for their affiliate groups. After much deliberation and consternation, the Board determined the best course of action was to move away from a formal chapter structure with all groups. DDNA hopes to continue its affiliation with these local networks and groups in a less formal manner. Final documents for transitioning these groups were received from the attorney and approved by the Board. Our organization has been a network of DDNA, and we are awaiting more information on how this may affect us.

New Corporate Membership Option: After much consideration and work, DDNA is now making group memberships available through a discounted "corporate membership" option. The corporate membership option is reserved for corporations/ entities that are interested in obtaining and maintaining DDNA nurse membership for at least 20 nurses. It is hoped that this will help those companies offer membership to more nurses at an affordable rate, making DDNA available to them as a resource. If your employer is interested in purchasing group memberships for DDNA through the corporate membership option, please have them contact DDNA at admin@ddna.org.

She has served on Springbrook's Informed Consent Committee, Incident Review Committee, and Human Rights Committee; she has also held health clinics for residents and staff and has helped to shape policies and procedures by offering her extensive knowledge of medical health. While continuing to work full time for Springbrook, Carol offered her advice and services to Joshua House and the ARC Otsego, where she assisted with medication certification and specialized training for employees.

Carol has been and continues to be a role model for outstanding care in the field of nursing. Carol is proud of her life's work and practice: "My heart is committed, and always has been, to serving people with intellectual and developmental disabilities and their families, as well as to training our staff and leading our teams! This unique field of nursing is

Because it's not just one specialty we're dealing with – it's a holistic type of nursing – it's all specialties together. There is always something new to learn about and to research, so that we gain more knowledge and, in turn, share this knowledge with others in the form of training and holistic approach, so that we can provide the best quality nursing care to those that we serve."

Carol has been an active member of the NYS ID/DD Nurses Association since 2006. As a member of the association, she has been a Zone 4 representative for three years, Zone 4 chairperson for four years, and co-chair for four years. Of the zones of the association, Zone 4 is the largest. Additionally, Carol has served as chairperson for the Nominating Committee, a member of the Conference Planning Committee, and has been co-chairperson for the Joyce Binder Memorial Award Committee. Currently, Carol is the association's recording secretary. She has been recognized for her many years of service and for her dedication to the people in her care, but also for her mentorship and compassion. Carol was nominated for this prestigious award by Karen J. Bazan, RN, BSN, Director of Nursing and Health Services at the Arc Otsego, and a 2017 award recipient. Karen is a fellow member of NYSIDDDNA.

In Memory of Kathy Keating, Our Colleague and Our Friend

For many of us, Kathy will be remembered as "the force" that formed us into nurses better prepared for the work we do. She inspired us to believe in our competence and was always willing to provide any guidance we sought.

Kathy was a strong advocate for manageable nursing caseloads. I recall Kathy coming to the agency I work for, instructing us that RNs needed to "visit each program weekly" and provide "24 hour nursing coverage" and, of course, "document" all of this. At the time the agency had 2 part time RNs with 44 hours total FTE. We had 9 programs across four counties requiring significant travel time. Kathy did not bat an eyelash when I inquired whether it was OK to just note "the RN crossed the doorway." We may still be struggling for nurses, but we have come a long way because of Kathy's dedication.

I recall Kathy piloting the first "Quarterly Nurse Update" during one of our Zone 4 meetings in Schoharie. Kathy then went on to "video-conference" her regular "Quarterly Nursing Updates" until she retired. I think every nurse who attended those updates longed for them to continue.

When I was the Chair of Zone 4, Kathy came to my house at the end of her workday to meet with an informal focus group of nursing leaders from several Capital District non-for-profit agencies. Kathy encouraged discussion, answered questions in "detail," and happily mentored those leaders. This was intended to be a commitment of three meetings over a year, but due to popular demand and Kathy's willingness, this group continued on for 3 years.

Kathy offered presentations for our Association conferences, even after her retirement. Kathy also presented regularly for the national DDNA conferences. She was truly dedicated to developing expertise in IDD nurses across the country.

At her wake, her husband, John, told me that up until a few weeks before she passed away, Kathy continued her work on a presentation for the national DDNA conference.

In her personal life, Kathy was also a world traveler. I used to kid her, that she needed to do a conference presentation for the nurses around where and how to travel in retirement because this would allow the rest of us to see the world through the pictures and stories of her travels with her family.

I feel fortunate that I was able to attend Kathy's wake. The video played was full of Kathy's travels with her family.

Kathy decided not to share her final journey details with many of us because she did not want us to worry about her. Kathy was one fine lady always looking out for us.
